When the Acting President and SSPC Chairman of the Republic of the Union of Myanmar arrived at the venue to connect the bridge parts with concrete, Union Minister for Construction U Myo Thant reported on the Myanmar-Korea friendship (Dala) bridge project.

2025 MULTIPARTY DEMOCRACY GENERAL ELECTION

- Domestic election observers who wish to monitor the multiparty democratic general election, which will begin in phases on 28 December 2025, may apply for election observation permits at the Union Election Commission (UEC), as well as the relevant Region/State, District, and Township Election Subcommissions from today until 5 December 2025.
- The Union Election Commission announced on 16 September 2025 that domestic election observers must follow the Code of Conduct for Observers, issued under Notification 68/2025, and adhere to the procedures set out for their observation activities under Notification 69/2025. These notifications are available for viewing and can be downloaded from the Union Election Commission's official website https://www.uec.gov.mm.
- The Union Election Commission has also announced that international election observers will be allowed to monitor
 the multiparty democratic general election. Invitations will be extended directly to representatives of relevant countries and international organizations. In addition, through the Ministry of Foreign Affairs, invitations will be sent to
 representatives of foreign embassies, consulates, and permanent missions that maintain diplomatic relations with
 the Government of the Republic of the Union of Myanmar.

Belarusian entertainment troupe tours Shwedagon Pagoda

A delegation of four Belarusian musicians and singers, led by Belarusian musician-cum-vocalist Mr Vladimir Sukolinsky, visited the Shwedagon Pagoda in Yangon yesterday morning to pay homage as part of their visit to promote friendship between Myanmar and Belarus.

The entertainment troupe first arrived at the Shwedagon Pagoda, where they were welcomed by the trustees and offered flowers, water, and oil lamps to the pagoda. Afterwards, they visited the Jade Buddha image and viewed the exhibits in the Buddhist Museum with interest. They then took a group photo at victorious Landplot and offered water to the pagoda. Finally, after examining the King Thayawady Bell, they visited the souvenir shop to buy souvenirs.

In the evening, the third goodwill concert of the Belarusian Music Ensemble was held at the RC Hall of Yangon University of Foreign Languages. The event was attended by Daw May San Yie, Rector of Yangon University of Foreign Languages; the vice-chairman of the Myanmar-Russia Friendship Association; officials from the Russian Embassy; and teachers and students from Yangon University of Foreign Languages.

Vice-Chairman Mr Alexander Ostrovskiy of the Myanmar-Russia Friendship Association delivered the opening speech at the ceremony. Then, under the leadership of Belarusian musician and vocalist Mr Vladimir Sukolinsky, singers Ms Nadezhda Bryleva and Ms Anzhelika Zaitseva performed a total of 17 songs,

including one about the traditional love between Russia and Belarus, another commemorating the 25th anniversary of Belarus–Myanmar friendship, a song about the historic city of Bagan, as well as various Belarusian traditional and contemporary pieces.

After the performance, Daw May San Yie, Rector of Yangon University of Foreign Languages, delivered a speech of thanks and presented the Belarusian artistes with honorary gifts.

The troupe arrived in Myanmar on 5 October and performed at Mandalay City Hall that evening, and at the Defence Services Technological Academy on the evening of 6 October. The Myanmar–Russia–Belarus trilateral concert will continue in Yangon and Nay Pyi Taw. — MNA/TH

Connection cemented for Myanmar-Korea Friendship (Dala) Bridge

The Acting President and SSPC Chairman of the Republic of the Union of Myanmar viewed around the progress of implementing the project and gave necessary guidance to officials.

The Myanmar-Korea Friendship (Dala) Bridge Construction Project was initiated following discussions held during former President U Thein Sein's state visit to the Republic of Korea in 2012, during which both countries agreed to implement a Myanmar-Korea friendship project in Myanmar. The project officially commenced in 2013, and pre-engineering works were completed by 2015. Design processes had begun in preparation for

the start of bridge construction. During the bridge construction period, progress was delayed due to challenges caused by the COVID-19 pandemic and other difficulties. However, after the current government assumed national responsibility, state funds were allocated to cover the remaining expenses, allowing the project to be completed. The Myanmar-Korea Friendship (Dala) Bridge is a cable-stayed steel bridge with four traffic lanes. The main bridge measures 2,264 feet in length, while the approach bridge on the Yangon side is 1,891 feet long, and the approach bridge on the Dala side is 1,972 feet long. The connecting roads on both sides total 3,453 feet in length,

bringing the overall length of the entire bridge to 6,127 feet.

The Bridge is the highest navigational clearance steel cable-stayed bridge ever constructed in Myanmar. With a clearance height of 160 feet and a width of 990 feet, it allows safe passage for large international ocean-going vessels weighing up to 15,000 tonnes, as well as domestic water transport ships to pass beneath it. The bridge is designed to support a maximum vehicle load of 75 tonnes per vehicle. Through the construction of this bridge, Myanmar engineers have gained valuable experience and technical expertise in the design, construction, and application of modern technologies related to steel cable-stayed bridge engineering. Upon the inauguration of the bridge, it will provide convenient and faster connectivity from Yangon Region and Yangon City to Dala, Twantay, Kawhmu, and Kungyangon townships, as well as through Dedaye of Ayeyawady Region, such as Dedaye, Pyapon, Bogale, and other coastal areas. It is also expected to help ease the current traffic congestion in Yangon City to a certain extent. Furthermore, the bridge will contribute to development across multiple sectors, including social, economic, educational, health, and transport sectors, and will become one of Yangon's significant landmarks. — MNA/TTA

ASEAN Economic Community (AEC) 2025 Implementation Committees' meeting held

THE meeting of the ASEAN **Economic Community (AEC)** 2025 Implementation Committees was held yesterday at the Ministry of Investment and Foreign Economic Relations, Office 1, Nay Pyi Taw. The meeting was led by Dr Wah Wah Maung, Union Minister for Investment and Foreign Economic Relations, and attended by deputy ministers and permanent secretaries who are the Chairs of 22 Working Committees, directors-general and representatives, around 80 participants in total.

In her opening remarks, the Union minister said that Myanmar has an unfaithful relationship in the implementation of ASEAN regional economic cooperation. She emphasized that as this year marks the final year of implementing the AEC 2025 Blueprint, the meeting aims to openly discuss the overall implementation status, Myanmar's progress and challenges, and to share updates on ASEAN vision 2045 and the upcoming AEC Strategic Plan (2026–2030), as well as to share the outcomes and follow-up actions from ASE-AN economic meetings held in September.

Union Minister Dr Wah Wah Maung also emphasized the

global geopolitical and geoeconomic challenges and their impacts on ASEAN, including Myanmar. To address these challenges, ASEAN has formed the ASEAN Geoeconomics Task Force (AGTF) to develop policy recommendations, and special ministerial meetings have also been convened to reinforce ASEAN's commitment to rulesbased, multilateral cooperation.

She also explained that the initial implementation of the AEC Blueprint (2016–2025) comprised about 1,700 action lines, which have now expanded to more than 3,800 in response to new and emerging issues such

as the COVID pandemic, sustainable development, and green economy. She added that more than 75 per cent of these action lines have been completed, and the goal is to reach 90 per cent by the end of 2025. Remaining actions will continue beyond 2025. She also encouraged relevant ministries to align national procedures with regional commitments to ensure smooth implementation of AEC-related agreements.

Furthermore, she stressed the importance of ASEAN Vision 2045 and its strategic plans across four pillars — Political-Security, Economic, Socio-Cultural, and Connectivity. The AEC will contribute through four consecutive five-year strategic plans. The AEC Strategic Plan (2026-2030) was endorsed at the 46th ASEAN Summit in May 2025. She also highlighted the need for a future awareness programme with stakeholders on the post-AEC agenda and encouraged sectoral agencies to provide continued support and coordination.

The Union minister urged all ministries to actively participate in AEC implementation to ensure Myanmar keeps pace with other ASEAN countries. She also called for timely reporting of implementation challenges and for stronger inter-ministerial cooperation on cross-cutting issues.

During the meeting, the Union minister shared the detailed updates of ASEAN Vision 2045 and its AEC Strategic Plan (2026-2030) and Dr Marlar Myo Nyunt, Director-General of the Department of Foreign Economic Relations and ASEAN Senior Economic Official, presented the outcomes and follow-up actions of the 57th ASEAN Economic Ministers' Meeting and related meetings, and the implementation status of AEC 2025.

Afterwards, the Chairs and representatives of the working committees reported on the implementation of the AEC measures and the challenges of the implementation, and their future directions. The Union minister provided guidance on the report of the working committees.

Myanmar has formed 22 sectoral committees to ensure the effective implementation of the AEC blueprint 2025. Each committee is chaired by deputy ministers or permanent secretaries, with directors-general serving as secretaries and relevant departments as members.

The meeting took place yesterday morning at the ministry's guest hall in Nay Pyi Taw.

During the meeting, Mr Montri Rawanchaikul briefed the Union minister on the company's plans to drill new wells in the declining Yadana and Zawtika

offshore projects to increase natural gas output, as well as preparations to expedite the signing of necessary agreements for new offshore projects.

The Union minister urged efforts to commence natural gas production from the new wells at the Zawtika Project in early 2026 and to strive for the first gas extraction from the new Aung Thitsa Offshore Project in 2028, which aims to supply natural gas for domestic electricity generation. He also reaffirmed that the Ministry of Energy is coordinating the necessary measures to ensure the swift signing of agreements.

Furthermore, the Union minister highlighted investment opportunities in new offshore projects with robust guarantees and invited PTTEP to invest in LNG import, storage, and distri-

bution projects through Kanpauk in Taninthayi Region, aimed at supplying natural gas to both domestic and Thai markets.

Also present at the meeting were the deputy minister, the per-

manent secretary, directors-general, managing directors, and senior officials from the Ministry of Energy, together with representatives from PTTEP International Limited. — MNA/KZL

World Sight Day 2025 marked in Nay Pyi Taw

THE ceremony to commemorate World Sight Day 2025 was held yesterday morning at the meeting hall of the Ministry of Health in Nay Pyi Taw.

Union Minister for Health Professor Dr Thet Khaing Win, ministry officials, and representatives from partner organizations attended the event.

In his address, the Union minister cited World Health Organization (WHO) estimates indicating that around one billion people worldwide live with vision impairment, of whom 90 per cent are from developing countries. He noted that 80 per cent of vision impairments are preventable or treatable. In Myanmar, major causes of blindness include cataract, refractive errors, eye injuries, glaucoma, diabetes, and hypertension. He also highlighted that the WHO officially declared Myanmar

free from trachoma in September 2020.

Although infectious eye

diseases such as trachoma have declined, the Minister stressed the need to strengthen the prevention and treatment of non-communicable eye diseases associated with diabetes and hypertension. Eye health checks have been integrated into school health programmes to improve children's eye care. To reduce cataract-related blindness, cataract surgeries are being performed not only in hospitals but also through outreach surgery programmes in rural areas.

This year's World Sight Day is observed under the theme Love Your Eyes — Share Knowledge for Better Vision and Value Eye Health. The Union minister urged everyone to prioritize eye health, undergo regular eye examinations, and support equitable access to eye care services for all.

Afterwards, the Union minister and attendees visited a mini exhibition and observed eye care activities and the distribution of eyeglasses. — MNA/KZI.

The Retreat of the Southwest Monsoon and the Weather Conditions Typically **Experienced in the Post-Monsoon Period**

Dr Kyaw (Meteorology School)

HE transition of the monsoon season's normally warm and humid weather to a slightly cooler and moister meteorological state, as the monsoon period nears its end, is a natural pre-indication that the region is preparing to enter the winter season. In regions located within the temperate zone of the Northern Hemisphere, such as China, Japan, Korea, and European countries, this temperature change is very distinctly felt. However, for regions like our Myanmar, which falls within the equatorial tropical zone, this change is not noticeably felt.

Nevertheless, this transition period is not a calm and gentle shift from one season to another. Instead, it is the most unstable period, where daily weather conditions can change rapidly (for example, sunny one moment and raining the next). For the Indochina Peninsula region (countries including Myanmar, Thailand, Laos, Cambodia, and Vietnam), the period from late September to the end of November can be roughly defined as the Post-Monsoon Season (or the Late Southwest Monsoon Period).

During this period, the weather events that can be encountered tend to be more severe and intense than normal, bringing significant challenges to people's livelihoods, health, agriculture, and local economies. Particularly due to the consequences of global Climate Change, it is observed that the meteorological conditions of this post-monsoon period are becoming noticeably more intense and severe.

Myanmar's Monsoon Rainy Season Cycle

The Indochina region, including Myanmar, is under the influence of the Northeast Monsoon and the Southwest Monsoon seasons. Generally, the pre-monsoon period begins around mid-May, the mid-monsoon period is from June to August, and September is the month when the southwest monsoon winds begin to retreat. According to research records, the months from October to November, before the Northeast Monsoon period begins, can be defined as the Post-Monsoon period.

During this period, the influence of the southwest monsoon on Myanmar diminishes, and it becomes a time when the country is more dominated by easterly wind waves from the east, as well as tropical typhoons. Furthermore, the northern regions of Myanmar also often experience the effects of westerly wind waves, which carry moisture from the Atlantic Ocean, travel across the Mediterranean region, and journey along the foothills of the Himalayas to the east.

Changes in Post-Monsoon Rainfall in Myanmar

The presented maps compare the total rainfall of Myanmar's post-monsoon period (i.e., the months of October and November) between the 1981-1990 decade and the 2010-2020 decade. According to Map (a), the regions receiving the highest rainfall are the already well-known Rakhine coast, the Ayeyarwady Delta region, and the Tanintharyi coast, while the central dry zone is seen to receive the least rainfall.

However, looking at the difference between the earlier 1990s decade and the post-2010 decade (Map-1-c), in the 2011-2020 decade, rainfall has significantly increased (shown in green) in many areas, including northwestern Myanmar (southern Chin State and northern Rakhine State), the Ayeyarwady Delta region, and the central basin region, including the Nay Pyi Taw Union Territory. At the same time, it was also found that rainfall has slightly decreased (red/orange) in some areas of the Tanintharyi coastal region. According to the Temporal Plot of average daily rainfall, the Laos, and even Myanmar.

average rainfall during the 2010-2020 decade was higher than in the 1981-1990 decade (Figure 2). In particular, from mid-October onwards, the average daily rate of the most recent decade (green dashed line) is significantly higher than that of the 1980s decade (blue dashed line), indicating that the pattern of rainfall received after the end of the monsoon season reflects either more intense precipitation or more rainy days.

Untimely Rainfall

The main cause of the abnormal rainfall occurrences in the post-monsoon period is the increased frequency of suddenly forming cumulonimbus clouds, wind waves, and storm phenomena in recent years. The post-monsoon period is a time when winds transition from westerlies to easterlies. Storms and wind waves from the western Pacific Ocean, depending on their intensity, can also cause rainfall events by carrying moisture and clouds along with the easterly winds.


Similarly, the intense sun of the post-monsoon period, which might lead one to believe the rainy season is completely over, heats the ground during

midday. The hot air in contact with this ground, which has accumulated moisture throughout the rainy season, rises rapidly and, due to physical processes, forms large cumulonimbus clouds (CB Clouds). These massive clouds cause post-monsoon rainfall events by generating lightning, strong winds, hail, and short periods of leading to river overflows and landslides. heavy rainfall.

Although these phenomena tend to occur in localized patches, their characteristically intense rainfall can cause sudden urban flooding in urban areas, and in rural areas, can lead to landslides and flash floods. Current research indicates that, alongside climate change, the frequency and intensity of these untimely rainfall events are increasing in many equatorial regions, including

The Threat of Storms in the Post-Monsoon Period

The phenomenon with the most dominant influence on the weather of the Indochina region during the post-monsoon period is typhoons from the South China Sea to the east. These storms, which form in the South China Sea and the northwestern Pacific, typically move westward or northwestward, affecting Vietnam, **Recommended Preparedness and Protective Measures**



On average, about 15 to 20 typhoons occur annually in the South China Sea, of which at least 4 to 6 usually make landfall on Vietnam's coastline. Some of these storms occasionally reach the Andaman Sea and the Bay of Bengal. Although these storms weaken upon landfall, they can continue to cause heavy rainfall

Similarly, in the Bay of Bengal during the post-monsoon period, cyclones and depressions occur more frequently than in the pre-monsoon period (April-May), but their intensity and likelihood of entering Myanmar are usually very low. However, studies in-the intensity of these storms is also likely to increase.

Flooding

Unpredictable, untimely rainfall can cause drainage systems to overflow and lead to floods in urban areas. Furthermore, heavy rainfall from cyclones can also cause rivers to overflow, submerging villages and farmlands. Delta regions and areas near rivers and streams in Myanmar are particularly prone to this hazard.

To systematically face and overcome the above hazards, the

following points are recommended:

- 1. Listen to weather news regularly. During the postmonsoon period, one should listen daily to the forecasts of the Department of Meteorology and Hydrology. If storm warnings or flood warnings are issued, people in coastal areas must be prepared to evacuate to safety.
- 2. Be cautious of flash floods. People living in low-lying areas, river valleys, and near watercourses must be especially cautious of flash floods. When it is raining heavily, one should avoid crossing deep water areas as much as possible.
- 3. Protect against lightning. When large cumulonimbus clouds are forming and during thunderstorms, do not stay outdoors in open fields, in water, or under trees. Take shelter inside sturdy concrete buildings.
- 4. Take special care of your health. To prevent illness due to temperature changes, one should eat foods that boost the immune system. In flooded areas, one should drink clean (or boiled) water to prevent water-borne diseases.
- **5. Farmers should** prepare in advance to protect near-harvest crops from rain damage. Monitor weather forecasts daily and perform emergency harvesting if necessary.

• Crop Selection and Scheduling:

- o Prioritize cultivating crop varieties that can be harvested at the end of the rainy season (e.g., early maturing paddy seeds).
- o Harvest timing should be planned based on weather forecasts.

• Emergency Harvesting and Threshing:

- o If heavy rain is forecast, emergency harvesting should be done if there is time.
- o Harvested crops should be stored in a dry place, safe from rain.

• Improving Field Drainage:

- o Regularly clean drains within fields to ensure good water flow.
- o Main drainage channels should be dug in advance to allow water to drain from fields quickly.

• Providing Sturdy Support for Crops:

o Use appropriate methods (e.g., tving rice paddies with ropes) to support crops and prevent lodging from strong winds.

• Insurance and Market Research:

- o Purchase natural disaster insurance and familiarize yourself with the procedures for claiming compensation for losses.
- Markets should be researched in advance to either immediately sell harvested crops or store them properly.

While the transition from one season to another is a beautiful part of nature, the post-monsoon period, due to its unstable daily weather patterns, requires us to be more vigilant and prepared Research today indicates that due to global climate change processes, post-monsoon storms and untimely rainfall are becoming more frequent and potentially more intense than in the past. Therefore, it is presented with the belief that by carefully listening to daily weather news and following the warnings of local authorities, we can safely overcome the meteorological

THE marine species and resource conservation are being carried out in 300,168.63 acres wide Lampi Marine National Park, which is located in Bokpyin and Myeik Archipelago in Taninthayi Region and surrounded by 26 small islands, according to the park official.

The Lampi Marine National Park covers an area of 57,344.03 acres of land and 242,824.6 acres of water, totalling 300,168.63 acres, of which about 75 per cent is for marine

animals, whereas 22 per cent is evergreen forest, two per cent is mangrove, and one per cent is spit.

"In the Lampi Marine National Park area, we are making collaborative efforts to conserve the coastal ecosystems, marine species and enrich marine resources. As some areas are inaccessible, and so we are working together, especially with the Tatmadaw (Navy). We conduct educational programmes in Salone areas, and work together

with the department concerned for plastic-free campaign and other educational programmes for Wa Ale Island," said U Thet Oo, director of the park.

The Lampi Marine National Park boasts 19 species of mammals, 228 species of birds, 19 species of reptiles, 11 species of amphibians, 42 species of fish, 42 species of crabs, 195 species of plants, 11 species of seagrass, 73 species of kelp, 136 species of phytoplankton, 150 species of zooplankton, and 63 species of

mangrove plants. The park is also home to endangered species such as the dugong, green sea turtle, Malayan pangolin, and near-threatened species, including the hairy-nosed otter, pig-tailed macaque, dusky langur, and various civets.

The Lampi Marine National Park features unspoiled beaches, beautiful marine scenery, rich mangrove forests, inland forest trails, and canoe-accessible mangrove waterways. It also includes turtle nesting grounds, rare bird habitats, and diverse aquatic ecosystems, making it a place of great interest for foreign tourists and for the marine animals, rare birds and forest researchers. Due to its high biodiversity and unique natural beauty, the park is an ideal location for research and has strong potential for nature-based tourism development, creating employment and livelihood opportunities for local communities. — Nyein Thu (MNA)/KTZH

Five-day illegal trade crackdown seizes goods worth K322M

UNDER the supervision of the Illegal Trade Eradication Steering Committee, efforts to combat the illicit trade are continued effectively by the law.

On 5, 6, and 8 October, the combined teams impounded consumer goods worth K12.71 million without official documents in Sagaing Township, two unregistered vehicles (approximately K12 million) at the Yadanabon bridge combined checkpoint in Sagaing Township and illegal teak, hardwood and other timbers worth K11.443 million in Bago and Toungoo districts. The action was conducted under Customs procedures, the Export/Import Law and the Forest Law.

Additionally, on 4, 5 and 6 October, the combined on-duty teams seized illegal fuel oil and diesel valued at K13.536 million in Kyaikmaraw Township and 27 unregistered motorbikes valued at K81 million in Mawlamyine

and Thaton districts. The action was conducted under the Petroleum and Petroleum Products Law and the Export/Import Law.

Similarly, on 2 and 8 October, the on-duty teams nabbed a Mitsubishi Fuso truck (approximately K40 million) carrying illegal teak worth K7.943 million at the junction of Hlegu-Satalin in Hlegu Township, a Toyota Corolla (approximately K30 million) carrying foodstuff worth K14.6 million without official documents at the Nyaungkhashay permanent checkpoint and industrial materials worth K99.75 million without official documents from a container at the Thilawa Port. The action was conducted under Customs pro-

The Steering Committee reported 40 arrests on 2, 4, 5, 6 and 8 October, seizing illegal goods worth approximately K322.982 million. — MNA/MKKS

Informant tips lead to arrests and seizures in illegal trade crackdown

SUPERVISED by the Illegal Trade Eradication Steering Committee, inspection teams under the state and regional illegal trade eradication special task forces, along with One-Stop Services led by the Customs Department, are consistently and effectively cracking down on illegal trade. These efforts take place at border trade offices and stations, permanent checkpoints along land and sea trade routes, and at ports and airports. For this, accurate information is crucial.

In September 2025, responsible citizens submitted 123 reports. Authorities seized 263 cases of illegal goods with an estimated value of K16,170.162 million. Vehicles and unregistered motorbikes were also confiscated.

Whistleblowers will be awarded 20 per cent of the estimated value of the seized items. Accordingly, departmental officials are arranging to distribute

CBM sells US\$1.9M to edible oil importers

THE Central Bank of Myanmar (CBM) sold over US\$1.9 million to edible oil-importing companies, in addition to sales of over 354,000 yuan in the market on 9 October.

CBM announced on 8 October that it would sell \$30 million to those engaged in the fuel oil industry.

CBM also sold over \$1.87 million to edible oil-importing companies and over \$530,290 to fuel oil-importing companies on that day, in addition to an injection of over 4.98 million baht and over 21,480 yuan into the market.

CBM injected over \$2.9 million into edible oil-importing

companies on 3 October 2025.

CBM sold over \$2.6 million to edible oil-importing compa-

nies and \$656,270 to fuel oil-importing companies on 2 October, in addition to an injection of

over 524,200 yuan into the forex market.

CBM announced on 2 October that it would sell \$25 million to fuel oil entrepreneurs.

CBM pumped over \$39 million purchased from companies working on a Cut, Make, and Pack basis into the market in September 2025. Moreover, CBM also injected over \$680,000, 6.2 million yuan and 300,000 baht into the market through the foreign exchange market online trading platform last month.

CBM sold over \$1 million, 11 million yuan and four million baht in August. Furthermore, CBM also pumped over \$32 million, purchased from the companies working on a Cut, Make, and Pack basis, into the financial market.

CBM aims to curb the instability in the foreign exchange market and currency devaluation. According to CBM's notification on 15 March 2024, it has been collaborating with law enforcement agencies to combat and prosecute those who attempt to manipulate the currency market under the existing laws. CBM allowed authorized dealers (private banks) to operate online foreign exchange trading freely as per the market rate, depending on supply and demand, starting from 5 December 2023. — NN/KK

Trade Dept revises Myanmar Tradenet 2.0 service fees

THE Trade Department under the Ministry of Commerce released an export/import newsletter 96/2025 that includes service fees of the Myanmar Tradenet 2.0 online portal and other digital platforms.

The amended ranges are K50,000 for annual member fee, K10,000 for online application fee, K50,000 for two-month export licence extension in the first time and K30,000 for onemonth extension in the second time, the set import licence fee for first time two-month extension and the second time onemonth extension, K10,000 for each amendment in export/ import registration, K30,000 for cancellation of export/import licence, K5,000 per month for the first and second renewal or amendment of export/import licence and K5,000 fine per month for the first and second renewal or amendment or cancellation of export/import licence starting from the expiring date.

Those reapplying for a licence after 14 days of expiry are not eligible for renewal. A permit for the amendment of the export/import licence needs to be obtained before arrival at the Myanmar Port and airports.

The Trade Department notified that the revised service fees are effective from 15 October 2025.

This bulletin will replace the previous bulletins 5/2018 and 18/2020 issued by the Department of Trade concerning the amendment of service fees for online licensing through Tradenet 2.0. — NN/KK

DICA blacklists six companies for unauthorized imports

THE Directorate of Investment and Company Administration (DICA) notified that six companies have been blacklisted for the pre-arrival of goods at the ports and airports.

DICA has already notified that the registrar will publicly declare the deny list and weak compliance matters on the DICA's website if companies registered on the online registry system, MyCO, fail to comply with the existing law, rules and bylaws of the government institutions concerned and provisions stipulated in the Myanmar Companies Law.

The Trade Department under the Ministry of Commerce informed DICA of listing six companies on the blacklist, and they were flagged for early arrival of the goods at the ports and airports. They are no longer permitted to run businesses under the existing laws starting from 23 May 2025.

Those companies are The Great Square Power Company Limited, Tharaphu Soe Myint Company Limited, Bai Long Ma Company Limited, Gold & Super Company Limited, Shine Dagon Company Limited, and Crown Kubota Myanmar Company Limited.

DICA announced last August that Myanmar Golden Mountain Company Limit-

ed failed to finish the last 15 per cent of the project for the RCC two-storey school building (BEHS Wahnetchaung) in Hmawby Township from the Union Fund of the 2024-2025 FY. Therefore, this company was blacklisted for three years from the 2024-2025 FY upon non-compliance with regulatory requirements under the existing laws and bylaws, according to the meeting decision 30/2025 held on 24 July 2025 of the Yangon Region government, DICA stated.

Two companies – KZO Myanmar Company Limited and Shwe Myine Yanant Company Limited – were blacklisted for two years from 20 June 2025 to 19 June 2027 for failing to abide by existing rules and regulations.

Those two companies did not comply with the tender

rules among 41 companies that participated in bidding for border development businesses under the capital expenditure budget of the 2025-2026 financial year allocated by Mon State's Development Supervision Office. They are found to violate tender rules according to the 20/2025 meeting held on 20 June.

DICA notified in the last week of July that seven companies have been blacklisted for the pre-arrival of goods at the ports and airports.

Upon the report of the Trade Department under the Ministry of Commerce, DICA put seven companies on the blacklist for early arrival of the goods at the ports and airports. They are no longer permitted to run businesses under the existing laws starting from 31 December 2024. — NN/KK


Mural restorations completed at Kyaiklat Chaung Pagoda and Tilawkaguru Cave

Myanmar earns US\$500M annually from maize exports

MYANMAR'S annual maize export is estimated at US\$500 million, and Thailand is the top importing country of Myanmar's maize, according to the Myanmar Corn Industrial Association.

Thailand accounts for 50 per cent of Myanmar's overall maize export, and 15 per cent goes to India, the Philippines, Viet Nam and China.

Myanmar bagged over \$500 million from maize exports in the 2023-2024 financial year, \$400 million in the 2024-2025 FY and over \$400 million so far in the current 2025-2026 FY.

Myanmar Trade Promotion Organization has been exerting efforts to explore new markets for maize exports beyond the existing trade partners. Myanmar Economic Attaches from Thailand, India, China, the UAE and the Philippines and representatives from the relevant institutions are distion matters. Value-added corn starch has earned high global demand. Consequently, Myanmar has been endeavouring to manufacture corn starch. Corn starch can be used in the pharma industry, the food industry and fertilizer processing, substituting imports. It can be exported as well when there is self-sufficiency, the Myanmar Trade Promotion Organization said.

Domestic consumption of maize is approximately 35 per cent of production, and the remaining is designated for exports. There are over one million growing acres of maize across the country, yet some growing acres are producing other commercially valued crops. Therefore, the growing acres might vary. The number of maize cultivation acres increased a bit in the current 2025-2026 growing season. — ASH/KK

S Korea's imported car sale logs double-digit growth in September

SOUTH Korea's imported car sale logged a double-digit growth last month due to strong demand for US electric vehicles and German luxury models, industry data showed Friday.

The number of imported vehicles sold here soared 32.2 per cent from a year earlier to 32,834 in September, according to the Korea Automobile Importers & Distributors Association.

For the first nine months of 2025, 225,348 foreign vehicles were sold here, up 15.7 per cent compared to the same period of last year.

US automaker Tesla ranked first in terms of automotive sales here among foreign companies by selling 9,069 units last month.

German automaker

Mercedes-Benz came next with 6,904 units, followed by German carmaker BMW with 6,610 units, Audi with 1,426 units, Lexus with 1,417 units and Volvo with 1,399 units. The number of European models sold here was 19,551 last month, taking up 59.5 per cent of the total. US, Japanese and Chinese brands recorded the market shares of 30.0 per cent, 7.3 per cent and 3.1 per cent each. — Xinhua

Carmakers face massive UK dieselgate lawsuit

FIVE major car manufacturers go on trial at London's High Court on Monday in the latest chapter of the dieselgate emissions scandal that has rocked the global car industry for a decade.

The High Court will decide whether systems installed in Mercedes, Ford, Peugeot-Citroen. Renault and Nissan diesel vehicles were designed to cheat clean air laws.

The five lead defendants deny the accusations.

The huge trial will have ramifications for other manufacturers, potentially paving the way for "billions of pounds" in compensation, said Mar-

tyn Day, lawyer at Leigh Day representing the claimants.

The dieselgate scandal first erupted in September 2015, when German automaker Volkswagen was found to have cheated pollution tests by installing so-called defeat devices to reduce nitrogen oxide readings.

It caused waves in the global car industry, ensnaring several other top carmakers and leading to legal action in several countries. - AFP

Indonesia seeks US\$5.5 bln investment to develop waste-toenergy facilities


INDONESIA needs an International Sustainabilinvestment of about 91 trillion rupiah (around US\$5.5 billion) to develop waste-to-energy facilities in 33 cities across the country, said Rosan Roeslani, CEO of the state investment management agency Danantara, on Friday.

"We cannot carry out this programme alone, so we are very open to collaborating with various partners, both local and international, to achieve this goal," Rosan said during the 2025 Indonesia

ity Forum (IISF) held in Jakarta.

He underscored that the waste-to-energy initiative would not only strengthen the national electricity supply but also deliver significant environmental and public health benefits.

The Portuguese was subsequently banned for four matches by European football's governing body UEFA.

The following day, Taylor was targeted by fans of the Italian club as he waked through an airport.

A chair and drinks were thrown in his direction before he was ushered to a safe area. — AFP



THOUSANDS of mourners lined the streets of Manchester on Friday as stars from the sporting world gathered to bid a final farewell to British former world champion Ricky Hatton.

Hatton, a popular, larger-than-life character who unified the light-welter-weight division and also won a world welterweight title, was found dead at his home last month.

Greater Manchester Police said they were not treating the death of the 46-year-old as suspicious.

Former world heavyweight champion Tyson Fury, ex-Manchester United striker Wayne Rooney and Oasis singer Liam Gallagher arrived at the cathedral for the service.

Gallagher was a long-time friend of Hatton, accompanying him on his ring walk against Paulie Malignaggi in 2008.

A funeral procession started at 9:45 am (0845 GMT) at the boxer's local pub, the Cheshire Cheese.

A truck carrying Hatton's yellow three-wheeler car was at the head of the funeral procession, with the name "Ricky" spelt out in flowers.

Stops included Hatton's boxing gym and the AO Arena, where he enjoyed some of his finest nights.

Following a private memorial service at midday, the procession was due to head to the Etihad Stadium, the home of Hatton's beloved Manchester City.

China announces export control measures on superhard materials, rare earths, battery-related items

CHINA'S commerce ministry and the General Administration of Customs on Thursday announced export control measures on items related to superhard materials, rare earth equipment and materials, and batteries.

Effective from 8 November exports of items related to superhard materials, equipment and raw materials related to rare earths, five medium and heavy rare earth elements including holmium, lithium batteries, as well as synthetic graphite anode materials, will not be permitted without approval, the Ministry of Commerce stated.

Given the dual-use nature of these items, the ministry said that China implements export control measures in accordance with laws and regulations, which conforms to international common practice and is in line with better safeguarding China's national security and interests, and better fulfilling its international obligations, such as its commitment to non-proliferation.

The Chinese government is willing to work with all countries to maintain the stability and smooth operations of global industrial and supply chains, the ministry said. — Xinhua
